This is a new event at Hollycombe which aims to add to the resident steam-powered fairground, railways and myriad other on-site attractions. If you would like to enter, please complete and return the attached Entry Form to the Rally Secretary, at the above address, no later than 15th August 2010.

Your engine must be insured against boiler explosion, third party and public liability risks including use on rally fields, with a minimum indemnity of £2,000,000 any one occurrence. You will be required to produce documentary evidence that such cover is in force before entering the Rally Field. If you have any queries on this matter, please contact the Rally Safety Officer.
